ENFORCEMENT CASE: Metro Recycling, Inc. and Eugene Calabrese, Solid Waste Enforcement Case #96-14795

RECOMMENDATION: Staff recommends that the EPC Board grant authority to take appropriate legal action, as necessary.

BACKGROUND AND NATURE OF VIOLATION: Metro Recycling, Inc. is operating a Materials Recovery Facility located at 1301 N. 27th Street, Tampa. The facility has been operating without a required FDEP permit since at least 1991. A Citation to Cease and Order to Correct Violation issued on March 29, 1996, was appealed, however Metro Recycling, Inc. has not been in compliance with the order to cease.

The EPC alleges violations of Chapters 1-1 and 1-7, Rules of the Commission and Chapter 62-701, Florida Administrative Code.
