

## Hazardous Waste Transporters

This list provides general information on hazardous waste transporters demonstrating the required financial responsibility who operate in the Tampa Bay area. The Florida Department of Environmental Protection (DEP) and the Environmental Protection Commission (EPC) of Hillsborough County do not necessarily endorse any companies appearing in this list. Furthermore, the absence of a particular company does not imply prejudice or impropriety. The DEP and the EPC recommend that a prospective customer contact a number of companies for the best service and price. Transporters reserve the right to evaluate the extent of their services on a case-by-case basis. It should be noted that some of the transporters on this list do not operate commercially. In general, governmental agencies, the military, and universities do not transport hazardous waste for other generators.
